OPEN TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING PUERTO RICO, THE U.S. VIRGIN ISLANDS, AND OTHER COMMONWEALTH, TERRITORIES AND POSSESSIONS), 13 YEARS OR OLDER.

DESCRIPTION of the CONTEST

As all of us, at one time or another, have had experiences in life that have been uplifting, happy, joyous, prosperous, favorable and, on the other side of the coin, we've experienced pain, suffering, confusion, humiliation and rejection, just to name a few, you get the picture. **Basic Theme:** This is a **CONTEST**. This contest requires paying particularly close attention to the lyrical content and messages of each individual song on the new release "The One" by Chris Jasper, the recognized multi-talented producer, composer, singer, song writer, musician, Hall of Fame Inductee, former member of the Isley Brothers and Isley Jasper Isley Bands and recent recipient of the Grammy Lifetime Achievement Award.
